The Board of Directors informs its shareholders that the Ordinary General Meeting held on 28 May 2019 decided to pay a final dividend of EUR 0.50 gross per share. After deduction of a withholding tax of 15%, a net dividend of EUR 0.425 per share will be payable as follow :
